BASIC REQUIREMENTS FOR INTERPOL RED NOTICE PUBLICATION

(Publish to locate and provisionally arrest a person pending extradition, surrender, or similar legal action)

Letter of request for publication from the investigating government agency/bureau addressed to:

- **Certified true copy of the following documents: Valid/standing Warrant of Arrest issued by a competent court**
- **Case Information** (must show the direct involvement of the subject person in the crime)
- **Resolution of the case** (if available)
- **Court Decision** (if available)
- **Identity Particulars of Subject** (full name, alias, date, and place of birth, name of father/mother, personal description)
- **Identifying Documents** (passport, driver's license, and/ or other similar documents)
- **Soft copy of the SOLO photograph in JPEG format** (must be recent, colored, gray background, raw, free from editing and download)
- **Travel Record from the Bureau of Immigration showing Outbound Travel** (if available)
- **Place/country likely to be visited**
- **Maximum Penalty of Charge**
- **Fingerprint in NIST format** (if available)
- **Name and contact details of the Investigating Officer and his Chief of Office** (to be notified by INTERPOL NCB Manila in case of any development)



**BASIC REQUIREMENTS FOR
INTERPOL BLUE NOTICE PUBLICATION**
(Published to identify, obtain additional information
and locate a person who is identified as
either Suspect, Victim, Wanted, or Witness)

- **Facts of the Case** (date, offense, place of offence, summary of personal involvement of subject in a crime)
- **If the subject is already detained, provide summary of the personal involvement of the subject, current status, and location of the subject**
- **Identity Particulars of the Subject** (full name, alias, date and place of birth, nationality, name of father/mother, personal description)
- **Identity Documents** (if available)
- **Soft copy of the SOLO photograph in JPEG format** (must be recent, colored, gray background, raw, free from editing and download)
- Fingerprint in NIST format (if available)
- **Name and contact details of the Investigating Officer and his Chief of Office** (to be notified by INTERPOL NCB Manila in case of any development)





**BASIC REQUIREMENTS FOR
INTERPOL BLACK NOTICE PUBLICATION**
(published to seek information on unidentified dead bodies)

- **Basic Information** (pertaining to the country of origin/nationality/ethnic group/possible identity)
- **Other Identifying Documents** (high-quality photographs, fingerprints, DNA, dental information)
- **Physical Description** (height, weight, build, hair, eyes, distinguishing marks and characteristics)
- **Facts of the Case** (date, country, region/town, circumstances of discovery, gender, approximate age, estimated time/date of death, presumed cause of death)
- **Name and contact details of the Investigating Officer and his Chief of Office** (to be notified by INTERPOL NCB Manila in case of any development)





BASIC REQUIREMENTS FOR INTERPOL GREEN NOTICE PUBLICATION

(Published to warn against subjects who are most likely to repeat a particular crime)

- **Identity particulars of the subject** (i.e. full name, alias, date of birth, nationality, name of father/mother, personal description)
- **Soft copy of the SOLO photograph in JPEG format** (must be recent, colored, gray background, raw, free from editing and download)
- **Physical Description** (height, weight, build, hair, eyes, distinguishing marks and characteristics)
- **Facts of the Case** (date of offense, place of the offense, a summary of personal involvement of the subject in a crime)
- **Identity Documents** (if available)
- **Place/country likely to be visited**
- **Name and contact details of the Investigating Officer and his Chief of Office** (to be notified by INTERPOL NCB Manila in case of any development)





BASIC REQUIREMENTS FOR INTERPOL ORANGE NOTICE PUBLICATION

(To warn about a person, an object, an incident, or a modus operandi representing an imminent threat to public safety and likely to cause serious damage to property and/or injury to persons)

CRIMINAL ACTIVITY

- **High-quality photographs/illustrations** (criminal activity likely to pose an imminent threat with description)
- **Identity Particulars of Suspect** (family name, forenames, alias, date, and place of birth, father and mother's name, nationality)
- **Identifying Documents of Suspect**
- **Physical Description/Distinguishing Marks of Suspect**
- **Regions/Countries likely to be Visited**
- **Fingerprints/DNA Profile** (if available)

OBJECT/DEVICE

- **Type of Object/Device**
- **Facts of the Case** (date, place/ country of discovery)
- **Circumstances of Discovery**
- **Description/Illustration of Object/Device**



PERSONS

- **Reasons why the individual is considered to be particularly dangerous**
- Identity Particulars of Suspect**

IF UNIDENTIFIED:

- **Fingerprints/ DNA Profile** (if available)
- **High-quality photograph**
- **Physical Description** (sex; height; weight; apparent age; hair; build; eyes)
- **Identity Particulars of Suspect/s** (family name; forenames; qualifiers; alias; date and place of birth; father and mother's name; nationality)
- **Identity Document/s of Suspect/s**
- **Physical Description/ Distinguishing Marks of Suspect/s**
- **Regions/ Countries likely to be Visited**
- **Fingerprints/ DNA Profile** (if available)

*(To seek or provide information on modus operandi objects,
